Burns and Lehon are accused of sending the negress, Annie Maude Carter, out of Atlanta after they obtained an affidavit from her, in which she alleged that Jim Conley had confessed to her that killed Mary Phagan. Judge Hill postponed the hearing after reading a tele-gram which Mr. Burns sent to his at-torneys in regard to his wife's illness. "You may rest assured that I shall be

on hand to answer these outrageous charges." he telegraphed.

Judge Hill will hear next Saturday the motion to set aside the verdict against Frank on the ground that he was not in court when the jury announced its verdict. Solicitor General Dorsey will call Frank's attorneys and Judge Roan, who presided at the trial, as witnesses for the State. It was understood that Frank's attorneys waived his presence, and that Judge Roan thought this a wise move because of the feeling manifested.

# Hebrew Aid Society Again Urges That He Be Allowed to Land. The Secretary of Labor notified the

Hebrew Sheltering and Immigrant Aid Society yesterday, in reply to its appeal on behalf of Mrs. Sarah Pogrebensky and her seven-year-old son, who had been ordered deported because he was feeble-minded, that she could land in New York provided a substitute was found to escort the boy back to Samarkand, Turkestan, whence he came. The manager of the Hebrew Sheltering and Immigrant Aid Society said last

night that the organization had sent a second appeal to Washington asking the Secretary of Labor to allow the boy to land with his mother under a bond that he would never become a public charge. The attention of the Secretary was called to the fact that the family had no relatives in Samarkand, their native city, and there was no one the boy could go back to. Mrs. Pogrebensky will remain on Ellis Island until a final answer is received from Washington.
