A Georgian Is Stirred Over Abuse of State

DEAR SIR: The unprecedented turn taken by the Frank case is enough to make the blood of every Georgian, and every lover of untrammelled law enforcement boil with righteous indignation. Slighter provocations have aroused the irascible temper of the editors and advocates of this commonwealth, to a heated defense of their State and section. But when an incited people of remote States—ignorant of the trial and the evidence—without the slightest idea of what is contained in the records of the court, save a few fragmentary snatches highly colored by partisans of the accused, his council and detectives—with minds prejudiced by paid for editorials, bought Hebrew talk and ignorant poppycock—when I say, people of this kind attempt to besmear the name of Georgia, those same editors and so-called advocates fawningly kow-tow to the ignorant defamers of their State by keeping silent while its name is being traduced.

When a few out-laws, from which no State is free, take the law into their own hands, as they did at Monticello, and disgrace civilization, we find our editors and advocates quick to spurn a proffered insult to our State by the prejudiced, misguided zealots of the North. But when our judiciary in whose hands lie the enforcement of our laws and, in short, the very bonds of our government itself, is held up to disdain and ridicule not a word do they speak in its behalf. Every day letters and magazine articles pour into the State of Georgia, maligning her courts and her people. Such articles when falling into the hands of the uninformed and when not refuted, are calculated to destroy the confidence so necessary to implicit reliance in the justice of our courts; and whenever the governed lose confidence in the courts, the bonds of government become slack, criminals and out-laws breed, and the people attempt to settle their differences by taking the law into their own hands. This forms the beginning of a fallen State.

When our press is so quick to resent any attempt to vilify the State because of incidents similar to the Monticello disgrace, and so reticent, with some notable exceptions, as to silently approve an arraignment of their judiciary by an infamous and totally ignorant people of other States, we shall do well to look for the reason. The cause of this is to a discerning mind at once obvious. The Frank case has been injected into politics (see Leo Frank's card in answer to ex-Gov. Brown); and the enraged Jews, generally speaking, are opposed to any business or enterprise in favor of enforcing the law as against Frank, in a word, the Jews have run a boycott wherever possible. This intimidation has not only brought to light the cowardice of our press but sits as a disgrace upon both the press and the State. What our press, generally, needs is a double-size injection of manhood.

Notice the letter sent by ten men to Rev. C. A. Hendley as published in *The Jeffersonian* of January 14, 1915. They do not base their plea upon the records and brief of evidence in the case, but upon the articles in "Collier's Weekly;" they do not claim nor profess to believe in the innocence of the accused, but hope that the future will bring forward such evidence as will necessitate a new trial. In other words, after reading "Collier's" they decided, without further evidence, that the trial was unfair and unjust; that without regard to the guilt of the accused, concerning which they have no opinion, he should be awarded clemency because he was convicted upon circumstantial evidence, and last, but not least, because C. P. Connally said so; that the judiciary of

Georgia is a humbug and a fraud for equally specious reasons; and that they have so decided and consequently by the authority in them assumed wish to set aside the findings and decisions of the court, decide the case from "Collier's," exclusively, in room 1232, 200 Fifth Ave., New York City, award the prisoner clemency by pardoning him out because he is a Jew, and because C. P. Connally and they, themselves, wish it done, in the hope the future will disclose wonders and perform miracles to convince us that he should have had a new trial.

The crime of which Leo Frank is accused is a crime against the laws of the State, and it is the function of the State to try him according to its laws. When this is done it is insolent and contemptible for a bunch of smart Alecks of other States to attempt to take matters in their own hands, insult our courts, slander our people and ridicule us to the world, without knowing a single thing about the case, and without any idea of it, save what has been spawned and hatched in prejudice and lies. It is enough to arouse the indignation of all right thinking people. And a press too craven to defend its State against such calumny deserves nothing but scorn and derision from the constituency of that State.

When has there ever been a case similar to this in the annals of our history? The State of Georgia has tried cases and executed its laws ever since it has been a State, and never before has it been vilified as it has in the Frank case, never before has there been such an effort by misinformed hoodlums of other States to nullify our laws and revile our courts. And when it is done in this case we may be sure that it is not done without money and without price.

Let us hope, Mr. Watson, that other daily papers and magazines will join you and Mr. Franc Mangum of the *Macon News* in defending our State and exposing the fraud that is so rampant in the Frank case campaign. Let us teach our Hebrew brothers and their sympathetic friends that when "the seed of Abraham," violate the law, all the money, editorial slobber-gosh, advertising campaigns, letter writing movements, and untra-State dictation and ridicule in Christendom, won't keep them from coming up to the trough and licking the salt like the rest of us.

Romanism teaches that all Protestants are heretics: that we fully understand. Romanism teaches that no marriage is legal unless the ceremony is performed by a priest or bishop: that we fully understand. Romanism believes that no person should have any mental reservation, but that they belong soul and body to the Pope: that we fully understand. Romanism believes that the Pope is the spiritual, and should be the temporal ruler of the world: that we fully understand. Romanism believes in forcing her religion on every person: teaching that to die outside

of the Roman Catholic church means punishment in hell, and to save any one from such a destiny it is their duty to force the mto accept Romanism: that we fully understand. In fact, it is because Protestantism understands Romanism so well that they are trying to avert the consequences of Romanist domination. Until Romanism got so open in her machinations, Protestantism lay dormant, secure in their belief that the days of the inquisition had passed; but, just as soon as Romanism begun to arise, and to shake off the false cloak of innocency, and to assert her political power, drowsy Protestants were aroused from the lethargy into which they had fallen, and once more asserted the great fundamental principles of true Democracy, Separation of Church and State. If Roman Catholics will stop their political intrigues and the attempted assassination of those who are exposing the corrupt practices of Romanism, then, and not until then, will true Protestants cease to protest.
