#### Will You Listen to This Voice From the Protestants of Ireland?

THE Belfast Weekly News of April 23, 1914, we clip the following:

THE AMERICAN PRESS AND ULSTER-AN APPEAL FOR FAIR PLAY .

The anti-Ulster attitude of the United States newspapers has long been proverbial. From time to time I have had to ventilate in this letter the grievances of many Protestant correspondents of the U.S. A. who had been refused access to the columns of the newspapers serving the localities in which they dwell, or who had their communications so cut down or altered that they were almost unrecognisable when published in a granding manner.

Why should this one-sided and most unfair state of affairs obtain in a great Protestant community? It must be remembered that the United States is one of the great Protestant nations of the world. The Roman Catholics number less than 20 per cent, probably not much more than 15 per cent of the entire population.

Why, then, is the United States Press so hostile to Protestant Ulster? The reason is a very Simple one. In the bad, old days when hatred of England was inculcated as an article of political faith in the United States, the English-hating Roman Irish took full advantage of that feeling to still further embitter the relations between the two countries, and only too successfully did they carry out their projects.

As time wore on, owing to their increasing numbers, particularly in such centres as New York, Boston, Philadelphia, Pittsburg, &c., they grew to be a tremendous political power, and in the course of years practically the political power of the older parts of the United States fell into their hands, and then began the disgraceful history of rings and "graft" which brought many a high head low, blasted many a reputation, and brought many to a well-deserved prison. In their

mad race to "get rich quick' the United States citizens left politics almost entirely in the hands of the Irish "bosses," who unscrupulously used the power thus left in their hands to serve their own dirty ends. The "Tammany Hall" ring was one of the agencies. Once every four years the citizens awakened to politics, found matters cut and dried for them by the political posses, and when the fever of the Presidential elections was over they returned once more to the game of annexing the "almighty dollar."

Bit by bit the Romish Irish tightened their grip on everything worth getting, they gained an absolute mastery of the Press, their well-organized voting battalions decided the battle of the polls, and soon every native American who wanted to represent his native country in this native Congress or Senate found that he had first to represent aliens in Ireland and their Americanised friends and sympathisers. Nor did the Irish gang stop at that.

To this day, the Irish possess the greatest political pull in the United States, thanks to their organization, which has been brought to the highest standard of perfection by the priests, the political bosses, and the drinking saloon keepers, for as in Ireland, the liquor traffic is almost practically in the hands of Roman Catholics. The Romish Church through its agents exercise an almost unbelievable power in the Press. Rome in effect says-"Support us and we'll support you." Such a bargain would be repulsive to Protestant feeling, which takes everything on its own merits and judges it accordingly.

In every hole and corner of the United States, Rome makes her power felt in the Government, in the Press, in the workshop and manufactoryeverywhere she exercises her full influences, and in most cases without the knowledge of those who shelter her. Her spies and agents are everywhere, nosing out everything that can possibly serve her ends. Her priests exulting declare that they hold power greater than the President himself, and one of them has gone so far as to damn the United States and its flag in public, and declare that the Church of Rome was superior to any Government.

MORGANTON WALROUT WAS DUE TO RELL. GION.

Twenty-Eight Men in Phishing Plant of Furniture Factory Quit Work.

Morganton, N. C., May 8 .- Religious differences are said to lie at the bottom of the walkout at the Morganton Furniture Company's plant Wednesday when 28 men in the finishing department struck on account of the refusal of the management to discharge the general foreman. The assistant foreman in charge of the finishing room says that the difficulty began some days ago, when the general foreman, who is a Catholic, asked him to remove a copy of the New Testament from the place. This was done, but according to the assistant foreman, J. C. Laughridge, the foreman has been growing more exacting and capriclous in his demands ever since. Wednesday he Laughridge, determined to throw up his job unless the other man was discharged. When the company supported the general foreman 27 other men, without any previous organization or agreement, followed Laughridge.

The company's side of the difficulty has not been made public.

Dear Sir: Since most of our peo-Die are either writing you their commendations of or talking about the decided position you have taken regarding the Frank case, while the Atlanta papers are filling their waste baskets with such communications and at the same time filling their readers with contempt, I see no reason why I should be an exception to the rule-therefore, this letter.

Your cry that justice be done and your plea for 'one law for the white, and the same for the black; one law for the rich, and the same for the Door" is being echoed throughout the Width and breadth of the grand old commonwealth whose very boundaries marked off a haven for the opbressed of mankind. A law-abiding, Justice-loving and God-fearing people are with you.

Georgians always have and ever will be proud of their state, her achievements and her hopes, her protection and her promises, her laws and her justice. And why shouldn't they be! A jealous guardian of her nonor and her dignity is Georgia. It occasions no surprise that, that dighity once insulted, that honor once libeled, her people should forget factions and prejudices and display a Public indignation, unusual in its unity of opinion and mighty in its restrained wrath.

The race, creed or personality of the accused Frank are matters of no concern to the people of Georgia, who hold no brief for any criminal, regardless of race or creed, but whose Drayer is that justice, and justice with be done in every instance, Without special consideration for the or class. have accepted the challenge. There is no wonder then that the people of Georgia as well as the rightly informed people of her sister states are with you almost to a man.

The case of Frank went through the courts of the state as any other similar case would have gone. Foilowing his conviction there came upon the scene much money, big detectives and many newspaper men. Then the case became a topic for the Nation. Some fifteen or twenty newspaper men were sent to Atlanta by the big metropolitan papers of the East. They heaped condemnation upon our courts, charged race hatred, cried "judicial murder," and classed Georgia justice with Russian persecution. The best newspaper "dopesters," one of whom was Hearst's Brisbane, were ordered to Atlanta.

Frank's Hebrew blood had nothing to do with his conviction. It weighed in the trial or with public opinion not one bit. He was no more convicted for being a Jew Lian was Beatie, the Virginia wife-killer, convicted because he was a Gentile, or Pastor Richeson of Boston for being a preacher. There is no prejudice for the great people of Israel in Georgia. Among them are to be found some of our best citizens. Many of them are our leading business men. They trade and traffic, lose and gain, just like the rest of our people, on the merit of their business and through their sagacity and their ability.

If his Jewish birth has played any part in Frank's case at all, it has not been against him as his lawyers and the detective Burns declare, but has worked to his benefit in that it is the wealth of wealthy Jews that is furnishing the men and the methods for his desperate after-conviction fight.

The part Burns has played in the case has been surprising to but few. Before Burns came down to set us aright there were thousands of persons in Georgia, among whom I place myself, who had never drawn an opinion as to the guilt or innocence of the accused man, but who, thankful that the responsibility of saying whether guilty or not guilty did not rest on their shoulders, rested in the confidence that justice would be satisfied in the courts of the land. But
