#### A GOOD WAY TO REACH AND TAX CONCLALED WEALTH.

Dear Sir: The Jackson County Farmers' Union this day in session assembled, and unanimously adopted the following:

That we call upon every local in Georgia to join us in a petition to the General Assembly, which convenes in June, next, to so amend our tax laws, that all wealth shall bear its proportionate part of the burden of taxation. We ask that the law be so amended that all evidence of debt, such as notes and mortgages, be presented to the tax receiver of the county in which held, that if the tax receiver and the owner of such evidence of wealth cannot agree upon the real value of such evidence of wealth, that it shall be submitted to arbitrators, whose decision shall be final; that all such evidences of wealth, shall bear the seal of the tax receiver, of the county in which they are held and owned, for each year after the passage of the act, or if not so called, shall not be collectable under the laws of this State; further, that all owners of merchandise of every kind shall make a full and complete inventory of his stock on hand, and swear to it before the tax collector; further, that the cashier of each and every bank, in this State, shall make a sworn statement to the tax receiver, of the county in which the bank is located, of all depositors in his bank, and the amount of each depositor.

As a class, we want to bear our just share of the burden of taxation, but under the present law we do not think we are justly treated.
